Welcome to the Bastrop ISD PATHS Project! The BISD PATHS Project is designed to help meet the needs of our Highly Mobile and At-Risk Student population which includes: McKinney-Vento, Foster care, Migrant, Military-Connected, and Pregnancy Related Services. The mission of the PATHS Project is to ensure that all students have access to programs, resources, and support that helps create PATHS toward their academic success.

Your student has been identified for the following program(s):

- ❑ McKinney-Vento: Subtitle VII-B of the McKinney-Vento Homeless Assistance Act, reauthorized in 2015 by Title IX, Part A of the Every Student Succeeds Act (42 U.S.C. § 11431 et seq.; hereafter the McKinney-Vento Act), guarantees educational rights and supports for students experiencing homelessness.
- ❑ Foster care: The general term “foster care” for education purposes includes all students in the managing conservatorship (legal custody) of the Texas Department of Family and Protective Services (DFPS). This includes students placed by DFPS with a Kinship caregiver when the child remains in the legal custody of Texas DFPS. Acceptable documentation includes all forms in the 2085 series.
- ❑ Military-Connected: Students in K-12th grade dependent on a current or former member of one of the following U.S. military; Texas National Guard (Army, Air Guard, or State Guard); or A reserve force. The student was a dependent of a member of the U.S. military or reserve force who has fallen in the line of duty. Pre-Kindergarten students are dependent on an active duty member of the armed forces of the United States including the state military forces or a reserve component of the armed forces who is ordered to active duty by proper authority. A dependent of the armed forces of the United States including the state military forces or a reserve component of the armed forces who is injured or fallen in the line of duty.
- ❑ Pregnancy-Related Services: Texas Education Code §29.081(d) identifies a student at risk of dropping out of school if the student is pregnant or is a parent. Pregnancy Related Services are support services, including Compensatory Education Home Instruction (CEHI), that a pregnant student receives during the pregnancy prenatal and postpartum periods.

Introduction

The BISD Family Resource Center's primary mission is to support families' capacity to raise healthy, well-functioning children, and promote student achievement and family engagement through a broad array of prevention and early intervention services. These services are developed and delivered according to the unique needs of families. The services specifically emphasize outreach to traditionally underserved populations to increase access to basic services and engagement in school.

Support at the center may include direct services, counseling, referrals, application assistance for benefits, and adult/parenting education opportunities. BISD families are welcome to utilize the following services:

- Social Connections
- Continuing Education
- Notary Public Services

At the Family Resource Center is also the BISD Health Clinic, which is a joint partnership between Community Health Centers of South Central Texas, Bluebonnet Trails, and the Bastrop Independent School District. This pediatric clinic is available to all BISD students and their siblings, takes most insurance, and offers a sliding scale for families without insurance. COMMON SIGNS OF HOMELESSNESS INCLUDE BUT ARE NOT LIMITED TO:

- **Lack of educational continuity**
- **Poor health/nutrition**
- **Transportation and attendance issues**
- **Social and behavioral concerns**
- **Reactions or statements by parents, guardians, or students**

These statements could include:

- **“I don’t remember the name of the last school.”**
- **“We’ve been moving around a lot.”**
- **“Our address is new.”**
- **“I can’t remember it.”**
- **“We’re staying with relatives until we get settled.”**
- **“We’re going through a bad time right now.”**

REMEMBER: HOMELESS YOUTHS’ POSSIBLE LIVING SITUATIONS COULD INCLUDE:

- **Living with friends (couch surfing)**
- **Living in shelters, transitional housing, motel/hotel**
- **Living in cars, campgrounds, abandoned buildings, public spaces, or on the street**
- **Living outside of the physical custody of their parent(s)**



WHAT SHOULD I DO NEXT?

- **If you or someone you know needs support or information about local and school resources, please contact the Family Resource Center at 512- 772-7151.**
 - **Reach out to the school’s counselor/support staff and let them know that the student/family may be experiencing homelessness.**
 - **Make sure the student/family has completed a new SRQ form (Student Residency Questionnaire) at their campus.**
 - **Tell the counselor/ support staff about any transportation issues the student might have. They may be eligible for bus passes or special transportation arrangements.**
 - **Let your counselor/ support staff know that the student/family needs food, toiletry/hygiene items, school supplies, and/or uniforms.**
 - **The Family Resource Center is here to help!**

RIGHTS OF A STUDENT OR PARENT EXPERIENCING HOMELESSNESS:

These include:

- **Keeping children in the same school even if they move and receive transportation to that school, as long as it is in the student's best interest.**
- **Enrolling in school immediately without the documents schools usually required**
- **Receiving free school meals.**
- **Getting help with school supplies and other needs**
- **Receiving extra support for youth who are on their own.**
- **Connecting young children with early childhood services.**

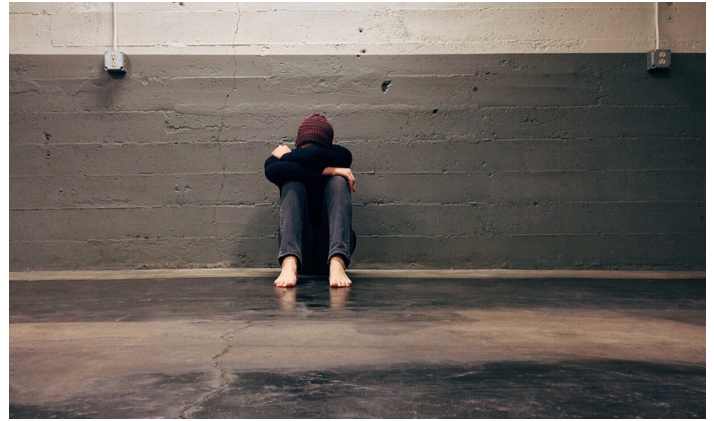
The PATHS Project Program:

- **Assists with enrollment, school transportation, and school supplies.**
- **Provides emergency food and hygiene items.**
- **Offers referrals to additional resources for food, housing, and other specific needs.**
- **Provides referrals to counseling and medical services as needed.**

Remember....

Homelessness doesn't always mean living on the streets — it includes being “doubledup,” living in shelters, living in hotels/motels, or anywhere that isn't a “fixed, regular, and adequate” nighttime residence. If a student/family identifies as homeless and would like to enroll at your campus, remember:

- They can attend any school of their choosing
 - They can enroll even if they are missing important documents, such as birth certificates, shot records, etc. (30 days).
 - Campus staff cannot ask for “proof” if a student/family is experiencing homelessness.
 - Students cannot be forced to change their enrollment status from a campus-based on their housing status (school of origin).
 - When a student is identified and coded as homeless (through the Student Residency Questionnaire), work with the BISD Family Resource Center to assist the family with necessary items and potential transportation support. Help is available!
 - We are all here to support our students and their learning. Lead with Kindness and Compassion!

IF YOU ARE A HOMELESS YOUTH OR KNOW SOMEONE WHO IS, HERE ARE SOME TIPS:

- **You don't need to feel guilty or ashamed.** Whatever happened to put you in this situation was out of your control. You are not to blame!
- **There are people who care.** Tell a trusted adult, such as a teacher, pastor, school liaison, principal, or counselor, about your situation. Letting authority figures know you are homeless will allow people to help you and get you the support you need.
- **Help is available.** In your school community, there are places and programs that help homeless youth stay in school, obtain services like access to food, showers, and medical care, and provide shelter and a safe place to sleep. Within seconds, you will receive a message with the closest Safe Place site and phone number for the local youth agency. You will also have the option to text interactively with a professional for more help. It's quick, easy, safe, and confidential.
- **Or, if you are in immediate danger, dial 9-1-1.** Don't be afraid to ask for help. You are worth it, and help is available!

Additional Information About Rights and Services Under the McKinney-Vento Act

Children and youth experiencing homelessness face unique challenges in accessing and succeeding in school. Subtitle VII-B of the McKinney-Vento Homeless Assistance Act, reauthorized in 2015 by Title IX, Part A of the Every Student Succeeds Act (42 U.S.C. § 11431 et seq.; hereafter the McKinney-Vento Act), establishes the definition of homeless used by U.S. public schools, and the educational rights to which children and youth experiencing homelessness are entitled.

What is the McKinney-Vento Homeless Definition?

The term “homeless children and youth”:

A. means individuals who lack a fixed, regular, and adequate nighttime residence...; and

B. includes –

- i. children and youths who are sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason; are living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations; are living in emergency or transitional shelters; or are abandoned in hospitals;
- ii. children and youths who have a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings...;
- iii. children and youths who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings; and
- iv. migratory children...who qualify as homeless for the purposes of this subtitle because the children are living in circumstances described in clauses (i) through (iii)

What rights do students have under McKinney-Vento?

The right to immediate enrollment. A school must immediately enroll a homeless student, even if the student does not have the documents normally required for enrollment, such as academic and medical/immunization records or proof of residency. Once enrolled, the Homeless Education Liaison of the school must help the family obtain the necessary records and/or immunizations.

The right to choose what school to attend.

- Students have the right to continue attending their “school of origin”. The “school of origin” is the school where the child or youth was last enrolled or the school the child or youth was attending when s/he became homeless. The school district shall keep a student in the “school of origin” unless it goes against the wishes of the parent. The student also has the option of enrolling in the school where he is currently living. (continued on next page).

- the school requested by the parent, the district must provide the parent with a written explanation of the decision, which includes the right to appeal the decision.
 - The school district must make placement decisions based on the best interests of the student.
 - If a student obtains permanent housing during the school year, the student has the right to stay in their current school until the end of the school year.

The right to transportation.

- The parent or guardian (or, in the case of an unaccompanied youth, the school homeless liaison) of a homeless student may request that transportation be provided to and from school. If the student is still in the same district as the school of origin, the school district must provide transportation. If the student is not living within the district of the school of origin, the district of origin and the district where the student is living must determine how to share transportation costs and responsibilities. If the districts cannot come to an agreement, then the responsibility and costs must be shared equally. In general, transportation time should be limited to one hour or less in each direction.
- Please note, the transportation provisions of McKinney-Vento only apply to students who are currently homeless. If a student obtains permanent housing and continues to attend his/her school of origin until the end of the school year, the continued provision of transportation is at the discretion of the district of origin.
- The right to participate in the same programs and activities as other students.
- Homeless students have the same rights as all other students to participate in School Nutrition, after-school, and special education programs
- Homeless students who qualify for special education services must be provided appropriate services based on the information that is available to the school. A school may not delay providing such services based on the non-receipt of school records.

Under the Act, every school district is required to have a Homeless Education Liaison. It is the job of the Liaison to ensure that homeless students have the same opportunities as all other students, which includes ensuring that homeless students are able to attend school, arranging for transportation in a timely manner, keeping the school staff informed of the rights of homeless students and providing appropriate referrals to service providers.

School Enrollment and Services for Foster Care Students

Under Texas law, students in foster care are entitled to immediate enrollment when arriving at a new school or district – regardless of whether they have the necessary documentation and paperwork. CPS caseworkers are required to enroll a child in school within three (3) school days of the child either: a) being placed in CPS custody; or b) moving to a new school or placement. The caseworker then has up to 30 days to provide all necessary enrollment paperwork to the new school.

Follow up to ensure a student:

- Has his or her records requested and received;
- Is placed in the appropriate grade level and classes;
- Receives his or her books; and
- Receives special education services, if appropriate.

Texas Systems Working Together to Transform Education Outcomes of Students in Foster Care
