1. Opening, Pledge, Presentations & Open Forum

A. Meeting Called to Order

President Allen called the meeting to order at 5:30 p.m. A quorum of board members was present. The meeting was duly called and notice of this meeting was posted in accordance with the Texas Open Meetings Act.

E. Student Speaker on Character Education Trait for September – Honesty Bridgette Helford, an 8th grader at Cedar Creek Middle School, spoke on the Character Trait of Honesty. Bridgette plays volleyball and basketball, is a member of PALS and National Junior Honor Society, and volunteers at the Bastrop Food Pantry and the Children's Advocacy Center. Bridgette's parents are Keith & Courtney Helford.

F. Introduction of Representatives of Superintendent's Student Advisory Council

Superintendent Murray introduced representatives from the Superintendent's Student Advisory Council – Natalia DePaz, a junior at CRCA, and Sutton Linsley, a sophomore at Bastrop High School. Mr. Murray thanked the students for attending tonight's meeting.

G. Special Recognitions

1. Recognition of BISD Students & Teachers for AP Incentive Program Dr. Jason Hewitt, Chief Academic Officer for Secondary Schools reported that in 2015-16, the district implemented an incentive/award program for students enrolled in AP courses, as well as the educators who taught those courses. He reported that students earing a score of 3 had any fees they had paid for exams reimbursed. In addition, student earning a score of 4 had fees reimbursed and received an additional \$200, and students earning a score of 5 had fees reimbursed and received an additional \$300. He added that teachers received the same corresponding amounts for students earning 4's and 5's on AP exams. Dr. Hewitt thanked the Bastrop Education Foundation for paying for some high school students to take the AP exams. Dr. Hewitt reported that students received \$17,416 in fee reimbursements, \$30,918 as award incentives and teachers received \$30,900 for a total of \$79,234 for the 2015-2016 school year. Dr. Hewitt thanked Mr. Murray for his leadership and his forward thinking.

2. Recognition of CRCA Teacher & Student Invited to the White House to Participate in a National Civics Workshop

CRCA Principal Martin Conrardy congratulated CRCA teacher Megan Brandon and CRCA student Natalia DePaz for being invited to the White House to participate in a national civics workshop sponsored by the Beeck Center and Civic Nation. Ms. Brandon and Natalia reported on their trip to Washington, DC and were appreciative for the opportunity.

4. Action Items

A. Accountability System Update and Consideration of District and Campus Improvement Plan Performance Objectives

Chief Academic Officers Penne' Liefer and Jason Hewitt reviewed drafts of the 2016-2017 District Improvement Plan and Campus Improvement Plan Performance Objectives. They reported that the District Plan encompasses the Strategic Design Goals and Objectives along with Performance Objectives and Strategies designed to be 1 year in length. In addition, they reported that the Campus Improvement Plans for the 15 campuses in BISD encompass the four Strategic Design Goals, and added that the campuses design and implement their own Performance Objectives and Strategies for 1 year in length. Dr. Hewitt reported that the district plan was developed by the Leadership Team of BISD, input from the District Performance Committee and Service Center Departments.

Ms. Liefer reported that Bluebonnet Elementary earned 2 distinctions, Cedar Creek Elementary earned 2 distinctions, Cedar Creek Intermediate earned 1 distinction, Bastrop Middle School earned 1 distinction, Bastrop High School earned 2 distinctions, Cedar Creek High School earned 2 distinctions, and CRCA earned 6 of 6 distinctions.

Mr. Mutschink asked principals to thank their teachers and staff, adding that the district has come a long way in the last 13 years. Mr. Mutschink thanked district

administrators and staff for their perseverance.

Billy Moore moved and Molly McClure seconded to approve the District and Campus Improvement Plan Performance Objectives as presented. President Allen asked for comments or questions. There being none, President Allen called for a vote.
