She added that the Debt Service Budget amendment includes the bond refunding entries, as well as adjustments to local tax revenues and state aid.

Ashley Mutschink moved and Matthew Mix seconded to approve the general fund and debt service budget amendments as presented. President Allen asked for comments or questions. There being none, President Allen called for a vote.
